The above listed items were released to Detective Klinzing of the Hemet Police Department to be booked into evidence. (See Detective Klinzing's supplemental report)

**DETAILS:**

The following supplemental report is regarding an officer involved shooting that occurred on August 16, 2020 at 560 N. Santa Fe Street in the city of Hemet, County of Riverside. The suspect, later identified as Ysidro Espinoza, was pronounced deceased at the scene by Hemet Fire Department.

On August 18, 2020, at 1051 hours, I attended the autopsy of Ysidro Espinoza. The Autopsy was performed by Dr. Schuman under coroner case number 2020-0876. All photographs and evidence were collected by Forensic Technician K. Morrow #N3857.

At the end autopsy Dr. Schuman stated Espinoza sustained multiple gunshot wounds. Dr. Schuman told me Espinoza had the following injuries:

**PENETRATING GUNSHOT WOUND TO THE HEAD** – The path of the projectile is slightly back to front, right to left and slightly downward

**PENETRATING GUNSHOT WOUND TO TORSO** – The path of the projectile is front to back, left to right and downward.

**PENETRATING GUNSHOT WOUND TO LEFT ARM AND TORSO** – The path of the projectile is front to back, left to right and downward.

**PENETRATING GUNSHOT WOUND TO LEFT ARM AND TORSO** – The path of the projectile is front to back, left to right and downward.

Dr. Schuman stated the official cause of death would be pending Coroner Review. For further information regarding the autopsy and cause of death, refer to the autopsy protocol.



