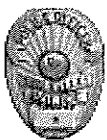
On 04/15/15 at approximately 1830 hours, Senior Officer Prchal and I were dispatched to 1590 Rambling Rd . I was driving a marked black and white Police vehicle and I was wearing a full Police uniform with Simi Valley Police patches on the shoulders. The reporting party contacted us to advise that Holly Billings acting irrational. She had hit the reporting party and .

Upon arrival, we met with the reporting party . stated Billings was in her bedroom sleeping. At the moment she was calm, however earlier she had struck . stated Billings had charged and started hitting and punching . had a small laceration on chest, but stated was not desirous of prosecution. They further stated Billings was not talking normal . gave us permission to enter the residence and check on Billings.

Senior Officer Prchal and I were aware of Billings' from several previous contacts with her. We knocked on Billings door and I opened it up to check her well being. I found Billings laying in her bed, smoking a cigarette. Immediately, Billings started rambling incoherent dialogue. I got her to come out of her bedroom and sit in a kitchen chair in the middle of the living room.

Billings continued to ramble off incoherent dialogue, counting and singing.

She kept saying someone had broken into her house and people were using heroin. Billings knew we were the Police based upon comments she made about us. We requested an additional unit based upon Billings' behavior. While waiting for Sergeant Meyer to arrive, Billings stood up from the chair and started dancing and singing in front of me. At this point she was approximately five feet away from me. Senior Officer Prchal was standing behind Billings in the living room area, approximately ten feet away. Billings proceeded towards me while she was dancing and singing, therefore I took a few steps back. At one point, Billings was approximately three or four feet away when she charged towards me with her both her fists clenched and her arms raised in the air. I also saw her gritting her teeth and her eyes were wide open. I was fearful of Billings striking me at this point.

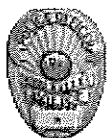

Billings' right fist then hit the upper left side of my chest/shoulder area with a moderate amount of force. To prevent Billings from hitting me again, I pushed her away from me and struck Billings in the face with my closed right fist with a moderate amount of force as well. I then used my right hand to grab her hair and pull her down to the ground in front of the chair. While I grabbed Billings by the hair, I heard Senior Officer Prchal remove his baton from the ring and I also heard him strike Billings before she went down to the ground. I did not physically see him strike her. We were unable to give Billings any commands due to her violent behavior. Once Billings was on the ground, I pulled her hands behind her back and placed her in handcuffs. Billings did not resist at any point once she was on the ground. Once Billings was on the ground, Senior Officer Prchal said, "Do not move or you will be batoned again." Sergeant Meyer arrived on scene shortly thereafter. Once the situation was under control, I felt pain in my right earlobe. It was throbbing and had a warm sensation. I do not recall when Billings struck my ear, but it may have been with her left fist as she came charging towards me. Senior Officer Prchal stated my ear was slightly red. I did not require medical attention at this time.

Based upon the circumstances, I placed Billings under arrest for 69 PC, resisting a Peace Officer and causing injury. She was taken outside and I examined her for any injuries. I lifted up her sweatshirt to view her back and noticed a five inch long by one inch wide abrasion to the upper left side. The abrasion was raised, slightly red and bruised (purple). It appeared consistent with a baton strike from Senior Officer Prchal. I also noticed a small red abrasion on the back of her upper right thigh. Billings was then transported to the Simi Valley Hospital where a medical clearance was obtained.

She was then transported to Ventura Main Jail where she was booked for the listed charge.

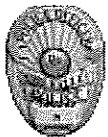

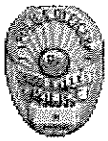

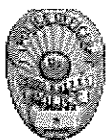
On 4-15-15 at approximately 1827 hours, SVPD Officer Jessica Neumann #435 and I (Senior Officer Prchal #349) responded to 1590 Rambling Rd. regarding a welfare check on Holly Billings.

Officer Neumann and I were both wearing complete department approved uniforms including fully marked Simi Valley Police shirts and badges. I was wearing a short sleeve shirt and Officer Neumann was wearing a long-sleeve shirt. At this time, I was 5'-11" and weighed approximately 166 pounds.

We spoke to [redacted] and [redacted] on the driveway who stated that they were at the residence to care for the animals at the property and check on Holly. [redacted] was concerned that the animals were not being properly cared for by Holly. During their short time at the residence, Holly attacked [redacted]. Holly punched [redacted] several times and scratched [redacted] chest. I observed an approximate 3" scratch on [redacted] chest. [redacted] was non-desirous for prosecution and declined medical attention. Both [redacted] and [redacted] wished for us to check on Holly's well-being.

The front door of the residence was open and we located Holly laying on the bed in her bedroom. The house was in disarray and I observed piles of trash and broken items, including glass, in the entry, kitchen and living room area. We asked Holly to exit the room and she willingly complied. Holly sat in a wooden chair in the living room and we attempted to speak with her. Holly refused to answer our simple questions and was yelling at Officer Neumann and I. Holly yelled that we "Raped her daughter" and asked us "Who are you?" and "How did you get in my house?" Holly also yelled random numbers repeatedly and rapidly for 15-20 second bursts for no reason. Holly then stated a phrase similar to, "Why are the fucking cops in my house?"

I looked Holly in the face and clearly told Holly that we were the "Simi Valley Police" and that we were only there to "Make sure you're OK". Holly continued to yell random phrases and become more agitated. Due to her behavior, I requested an additional unit to respond to our location through

SVPD Dispatch. I activated my department issued audio recorder.

Holly was sitting in the middle of the room. Officer Neumann was standing approximately 5' in front of Holly and I was standing approximately 10' behind and slightly to Holly's left. Holly continued to yell and scream at us. Holly then stood up and sang portions of several songs and danced around directly in front of Officer Neumann. Neumann told Holly to "Sit down". Holly completed a 360 degree turn then stepped towards Officer Neumann. Neumann retreated backwards approximately 3' to move away from Holly. I then told Holly three times to "Sit Down". Holly then stepped towards Neumann in a aggressive manner with her right arm raised and her right hand in a fist. I observed Holly strike Neumann on the upper torso/neck region above Neumann's badge one time with her fist. The strike was strong and was clearly an attempt to harm Officer Neumann. Holly did not stop or retreat and attempted to again strike Neumann with her left fist. Holly's back was facing me when she attacked Officer Neumann. Holly's attack on Neumann was completely unprovoked.

At this point I considered the following: Holly's behavior towards
was violent and aggressive

. Holly committed a felony battery on a uniformed Police Officer during the scope of our legal duties. Holly was wearing a thick, athletic style sweatshirt and blue jean shorts. Based on this attire, my Taser would potentially not be effective. I deployed my 26" straight stick and struck Holly in the upper torso (Zone 1) on the left side of her back. The two-handed strike was in a controlled fashion, of moderate force and in a department approved manner. Holly continued to stand in front of Officer Neumann and attempt to punch her with her fists. I yelled at Holly to get on the ground or she would be struck with my baton again. I believed that Holly was still attempting to strike and harm Officer Neumann. I then struck Holly with my baton on the back of her right leg with moderate force (but with less force than the fist strike). Officer Neumann pushed Holly to the ground and Holly landed on her chest/stomach area. Holly stopped actively fighting with us and Neumann handcuffed Holly without further incident.

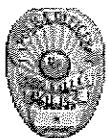
Due to Holly's rapid and unprovoked attack, I was unable to give Holly any warnings regarding the baton strike. I formed the opinion that other force options (Control hold, Taser, O.C. Spray) would not be as effective in this situation as utilizing my baton.

I asked Holly if she was injured or needed immediate medical attention and she declined treatment.

I observed that Officer Neumann's right ear was red and swollen. Neumann had an approximate 1/2" by 1/2" red mark on the front of her neck.

I was not injured during the incident.

Officer Neumann arrested Holly for 69 PC.

Follow Up Report # 1

Sgt. Meyer arrived on scene and completed his Use of Force investigation. The residence was photographed.

There were no witnesses to the incident. and were outside during the altercation.

We examined Holly and I observed an approximate 5" by 1" contusion on the middle/left side of her back consistent with a baton strike. The mark was slightly raised and had a purplish color (Bruise). The back of Holly's right leg had a faint red mark that was approximately 1/4" by 1/4".

Officer Neumann transported Holly to Simi Valley Hospital and I followed.

I attempted to read Holly her Miranda Rights but she yelled over me while I read from my department issued card. I did not question her regarding the incident.

Sgt. Meyer responded to the hospital and took photos of Holly.

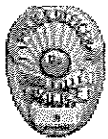
Officer Neumann transported Holly to Ventura and she was booked without incident.

Sgt. Meyer booked the audio recording of the incident into evidence at SVPD.

Refer to Officer Neumann's Arrest Report for further details of the incident.

Of note, SVPD Officer Mcalister contacted Holly today at approximately 1530 hours at First St. and Fitzgerald Rd. She was the subject of a radio call after she was observed walking in the street. Holly was walking home and per Mcalister, . Mcalister told me that she was obeying all traffic laws and the traffic conditions as she walked towards her residence. DR15-15506.

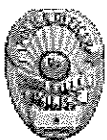

On April 15, 2015, I was assigned as a Field Supervisor driving a marked black and white police unit. At approximately 1917 hours, I responded to 1590 Rambling Road to assist Senior Officer Prchal and Officer Neumann with a call for service involving Holly Billings. I was familiar with Holly from dealings with her

Upon arrival, I entered the residence through the open front door. I observed Holly laying on her stomach handcuffed in the front room. She was rambling on making nonsensical comments.

I spoke with Officer Neumann who told me she and Officer Prchal contacted and to the front of the residence. They were assaulted earlier by Holly but they were not desirous of prosecution. They only wanted her checked on

They contacted Holly in her bedroom and convinced her to speak with them in the front room. There, Holly attacked Officer Neumann by striking her in the upper chest with a closed fist. While fighting with her, Officer Prchal struck Holly twice with his baton. See Officer Neumann's report for further details.

I spoke with Senior Officer Prchal who related essentially the same account. He said that when Holly struck Officer Neumann with a closed hammer fist, he removed his baton and struck Holly once on the left side of her back and once on the lower right buttock. These two strikes caused Holly to fall to the ground where she was handcuffed. See Senior Officer Prchal's report for further details.

We inspected the area of where Holly was reported to have been struck by the baton. The back of her shirt was lifted half way up and I could clearly see an area that was raised and purple, approximately 6 to 8 inches long, consistent with a baton strike. Officer Neumann raised the right cuff of Holly's shorts and I observed a light red mark. I took digital photographs of the injuries and later booked them as evidence. I also took digital photographs of the scene.

At approximately 2030 hours, I responded to the hospital to interview Holly. Senior Officer Prchal told me Holly had already been admonished

regarding Miranda rights. It was unclear if she was even able to conceive them.

I engaged her in conversation by asking her what happened at the house. She started counting and then changed her thought by saying "I train football players". I concluded my interview shortly thereafter. A copy of the recording was later booked into evidence.

On 4-16-15, Senior Officer Prchal allowed me to listen to an audio recording of the incident. He had activated his department issued recorder part way through their contact. The recording was consistent with the officers' account of what occurred. In addition, Officer Prchal advised Holly that she would be struck again if she tried to resist anymore. I arrived shortly thereafter. Officer Prchal booked the recording into evidence.

I completed a Use of Force Investigation / Tactical Analysis.

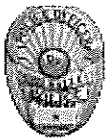
