### Incident Summary

On 2/26/16, at approximately 2117 hours, Corporal G. Couso #2867 was conducting a patrol check of Santa Anita Park, 300 S. Figueroa. He came in contact with a subject known to him from prior contacts, Antonio Carrillo. While speaking with Carrillo, Carrillo discarded a sunglass container, which opened when it hit the ground. The container opened and Corporal Couso observed syringes inside the sunglass container. As Corporal attempted to handcuff Carrillo, Carrillo turned and punched Corporal Couso. A fight ensued between the two and Corporal Couso took Carrillo to the ground in the parking lot of the adjoining strip mall. Corporal Couso advised over the radio he was in a fight with a subject and requested additional units. Officer Raya #3345 responded code 3, and arrived to find Corporal Couso and Carrillo still on the ground. Carrillo appeared to still be fighting with Corporal Couso. Carrillo was punched several times by both officers as they attempted to control Carrillo's active resistance, and handcuff him. Officer J. Rodriguez #1997, also arrived on scene and assisted in handcuffing Carrillo.

Once Carrillo was handcuffed, he settled down, and OCFA arrived on scene and treated Carrillo. Carrillo had redness/abrasions to the right side of his head, and complained of pain to his head and right shoulder. According to Corporal Couso, at no time did Carrillo lose consciousness.

Carrillo was advised of his Miranda rights by Corporal Couso, and he refused to speak. I then advised Carrillo that I was conducting an administrative investigation, and that I would like to see his injuries. I verified the above injuries, and Forensic Specialist Parent #2694 photographed his injuries. She also photographed the scene, and the fact that Corporal Couso's uniform was ripped and disheveled.

There were no independent witnesses or surveillance cameras located at the scene. Carrillo did not make an allegations of excessive force by any of the officers.

Carrillo was transported to the Santa Ana Jail to be booked for 243 PC, 11364 HS, and 647(f) PC. At the Santa Ana Jail, medical personnel requested that Carrillo be medically cleared at the hospital. He was transported to OC Global for medical clearance. At OC Global it was determined that Carrillo had sustained a fractured collar bone. Based on this information he was going to be kept for observations. With the approval of Watch Commander, A/Commander Claborn, Carrillo was cited out for the above charges.

### Narrative:

On February 26, 2016, I was working uniformed Park Enforcement and driving a marked Santa Ana

Police Department vehicle. I have been a Santa Ana Police Officer for approximately 11 years and I have worked the Westend Policing District for approximately 2-3 years. My current assignment is as a Park Enforcement Liaison Officer, working with Santa Ana Parks and Recreation staff and providing security and enforcement to the (41) community parks in the city.

On the same date at approximately 2105 hours, I conducted a patrol check at Santa Nita Park located at 300 N. Figueroa St, in the City of Santa Ana, County of Orange. The Santa Nita Park is located within the Westend Policing District.

I am very much aware of the illegal activity and quality of life issues that are presented here at Santa Nita Park. Working as a police officer and now in my current position, I have been a part of many contacts and arrests at this park ranging from individuals consuming alcohol in public, illegal gang activity, narcotic activity and illegal camping involving homeless individuals.

In my capacity as a Westend District police officer and now as a Park Enforcement Liaison Officer, I have been to several meetings here at this park with local residents. Some of the most recent and notable concerns involving this park are, homeless individuals using narcotics near the recreation center and bathroom, homeless individuals illegally camping and the presence of gang members loitering during soccer practices and games.

This evening while driving southbound on Figueroa St, towards the entrance of Santa Nita Park, I saw a male Hispanic subject who I immediately recognized from a prior contact and two arrests as being (A#1) Antonio Carrillo. I recalled during my contacts with Carrillo, that he stated he was homeless, associated in some form with the criminal street gang "Santa Nita" and sometimes sleeps at the park. During my prior contact with Carrillo he was always intoxicated and somewhat cooperative.

As I drove past Carrillo, who was seated on the sidewalk with his feet in the street at the entrance of the park, I made a U-turn in the parking lot of the park and drove towards him. I saw now that Carrillo's head was hung down, his arms were hung loosely in front of his body and he was seated there motionless. In believing that Carrillo could be in the need of medical assistance (Based on the way he was seated motionless and with feet into the street) I wanted to contact him to first check on his welfare.

I next stopped my police unit approximately 5-10 feet away Carrillo, in a fashion to prevent him or even myself from getting struck by passing motorist. While walking towards Carrillo, he must have alerted to the sound of my police radio and quickly lifted his head up and looked directly and me.

I asked Carrillo "are you ok, why are you here." Before I could get a response about his wellbeing, Carrillo said with slightly slurred speech "Fuck you again cop" and he slowly rolled to the left side of his body and attempted to get up off of the sidewalk on his own. I saw that Carrillo had a difficult time attempting to get up and I asked him a second time "Are you ok, do you need help." Carrillo then a second time looked directly at me and said in English once again with slightly slurred speech "Fuck no, you know me I drink (*incoherent word/ speech*)..... much."

Now standing a little closer to Carrillo, I could smell a strong odor of an alcoholic beverage emitting from his person. Based on the slurred speech and odor of alcohol, I now believed that Carrillo was under the influence of alcohol.

My contact with Carrillo seemed to be moving very quickly and I really did have time safely and early into my contact and questioning to advise police dispatch of my activity. I felt based on Carrillo belligerent behavior (verbal cussing) I need to take him into custody for public intoxication. At this point, Carrillo somewhat "calmed down" and allowed me to help him up off the sidewalk and out of the street.



Carrillo was wearing a dark colored hoodie sweater and during my contact with him it was not particularly cool out and I found this somewhat to be strange. (A local weather check after this entire incident showed the approximate weather as low to mid 70's, from a local website) Now I know based on my training and experience as a police officer, Field Training Officer and working at the Orange County Sheriff's Academy training police recruits. I have knowledge that violent offenders will sometimes wearing bulky or layers of clothing even when the weather does not suit it for the fact to conceal illegal weapons or contraband. So based on the fact that Carrillo was wearing a heavy sweater in this warm to moderate weather it made be nervous.

Once Carrillo stood up I asked him if he had any illegal weapons, drugs or anything that might hurt me. Carrillo stood facing me and I could tell that he had a tough time mainting his balance, said "no" and then reached into his front sweater pockets. Once again at this point things were moving in a fluid fashion and I felt that I could not back off to use my radio at this time.

I then asked Carrillo to please remove his hands from his front sweaters pocket. Carrillo in one motion removed his left hand and discarded what I could clearly see was an eye glass container onto the sidewalk. Also what I noticed was during my contact with Carrillo I did not need the use of my flashlight, because we were both standing near and overhead working street lamp that illuminated our area and sidewalk.

Once the eye glass container struck the sidewalk, it popped open and I saw two hypodermic needles fall out on to the sidewalk. What I would have to describe as, we both simultaneously looked down at the needles at which point I quickly took a step forward and grabbed onto Carrillo's left wrist.

At this point after seeing the needles and knowing that Carrillo had not been patted down for weapons, I believed that he could be armed with more contraband even a deadly weapon. While holding on to his left wrist, I intended to place him under a lawful arrest for possession of hypodermic needles.

I was able to simply tell Carrillo to turn around and to place his right hand behind his head. This was the only verbal command that Carrillo complied and listened to. Once Carrillo had his back towards me, I took control of his fingers to safely place my handcuffs on to him. I was able to set and lock one handcuff on his right wrist at which time, Carrillo violently lunged forward, quickly swung his entire body to the right, now facing me and punched me once his a closed fist in the center of my upper chest. After being punched by Carrillo, it caused me to slightly fall backwards thus almost losing my balance. However, I was able to hold on to the handcuff that was still attached to his right wrist.

Once Carrillo struck me, he quickly turned back around and attempted to break free from my hold by trying to run off. I was able to hold Carrillos body weight and slightly prevent him from running as I screamed "**Stop running, stop fighting.**" Carrillo abruptly stopped moving forward, and for a second time began to twist his body towards me. In fearing that he was going to punch me a second time and possibly cause me to get injured. I quickly pulled on the handcuff and pulled his body closer to me and then struck him with a open left palm to his face and as he hunched forward, I struck him a second time with my left elbow to the right side of his face.

I felt the tension of Carrillo still trying to pull his right arm away from me and I believed the palm strike and elbow strike were no effect to him. During this violent encounter with Carrillo and the fact that he still had not been searched and his left hand was free, I had no other option but to let go of his right hand. I felt that it was time to create some distance from Carrillo and possible utilize some other appropriate force technique to end this incident and to take Carrillo into custody. I know with the free handcuff it can be used as a weapon, but I felt I could gain some distance to relay on another technique.

Once I took a step back and gained some distance, (*only approximately 2-3 feet, still considered close quarters for a violent attack*) Carrillo quickly walked towards me with his body hunched forward and



his head down as if he was charging at my waist. I felt if he took control of my waist, he could aggressively throw me down to the hard ground. I know through my training and officer safety experience, if I am taken down to the ground I could strike my head which will cause me to lose consciousness. If I lose consciousness I know that Carrillo based on his previous assaults on me, would take a weapon of mine and use it against me.

To prevent Carrillo from inflicting any more attacks and assaults on me, in the position that he was coming at me, I placed both of my hands around the back of his neck, held my hands tight and pulled his body downwards. As I held Carrillo's upper body, I could feel him trying to pull away. At this time I then kned Carrillo three times in his face at which time we both fell to the ground. Carrillo fell face forward into the park lot and I fell onto my knees.

I noticed at this point, we were no longer on the sidewalk which was the scene of the initial contact but were now several feet into an adjacent parking lot.

Once Carrillo and I were in the parking lot and on the ground, I was trying to use my body weight and place my body on his upper back. I felt Carrillo moving around and attempting to use both arms to "push up" off the ground while we was "grunting". During this time I felt sharp pain to my knees and felt that I need to maintain a tactical advantage by keeping ahold of Carrillo. As I was attempting to hold down the right portion of his body, I saw his face came off the ground as he started to twist his entire body to the left and try to break free. I could now feel the 200lbs of his body weight against mine starting to twist and move. I yelled at Carrillo **"Stop fighting, stop moving,"** but Carrillo refused to listen and continued to move his body. Carrillo then yelled **"Get the fuck off."**

I the felt that if he was able to get to his feet this quick violent encounter would continue. So I then with my right elbow struck the left side of his face in order to stop this incident. After the elbow strikes, I felt his body to stop moving. I was then able to grab onto his left wrist and handcuff.

While holding onto the handcuff and using my bodyweight to hold him down, I was now able to use my radio and advise police dispatch that I had just been involved in a fight and requested a Code-3 (*Emergency lights and sirens*) response for help.

SAPD Officers J. Rodriguez #1997 and G. Raya #3345, were the first two officers to arrive in the parking lot. At this point I felt very exhausted and still experienced pain in my knees. I then passed Carrillo's left hand to Officer Raya. Officer Raya and Officer Rodriguez were then both able to place the handcuffs securely onto Carrillo thus ending this quick and violent situation.

As I earlier stated, I have had previous contacts with Carrillo and they were somewhat peaceful nothing like what occurred this evening. Tonight's incident occurred very quickly and was a surprise to me based on his demeanor and violent attack on myself.

Once the situation was under control, I requested OCFA to respond to the scene to medically treat and evaluate Carrillo. While in the parking lot, Carrillo was medically cleared by OCFA for jail booking. SAPD Forensic Specialist T. Parent # 2694 also drove to the scene and took digital photographs of Carrillo and myself. During this incident Carrillo damaged my police name tag, uniform shirt, pants and I sustained slight pain to my knees.

Sergeant D. Park #2790 arrived on scene and assumed scene control and provided the necessary arrest approvals. The hypodermic needles were recovered and later booked into evidence at the Santa Ana Police Department, by Corporal S. Caro # 3134 and his trainee Officer M. Griffith #3422.

For complete facts involving Officer Rodriguez' and Rayas assistance please refer to their supplemental report under this same case number. Corporal Caro and Officer Griffith also completed a supplemental

report under the same case number for the control and booking of the evidence.

### INTERVIEW WITH ANTONIO CARRILLO

On February 26, 2016 at approximately 2134 hours, I read Carrillo his Miranda Rights per my Santa Ana Police Department issued Officers Index book. Carrillo related he understood his Rights and I asked him if I could speak with him about tonight's incident and arrest. Carrillo replied in English "**Fuck no I have nothing to say.**" I did not ask Carrillo any questions and at no point did he request to speak with a lawyer.

Carrillo had no active warrants for his arrest and a criminal history check on him revealed [REDACTED]

**Narrative:**

On 2-26-16 at approximately 2117 hours, I was working uniformed patrol driving a marked black and white police vehicle. I was wearing department issued police uniform in the area of 400 N. Figueroa when I heard Cpl Couso asking for help over the police radio. I responded to 300 N. Figueroa and arrived at that location with Officer Raya.

Upon my arrival, I observed Cpl Couso in the parking lot across from Santa Nita Park on the ground struggling with Arrestee Carrillo. I assisted in taking Arrestee Carrillo into custody by applying my body with my right knee on his back. I then assisted in handcuffing Arrestee Carrillo.

I was assigned to transport Arrestee Carrillo from the Santa Ana Jail to OC Global Hospital for medical clearance. While transporting Arrestee Carrillo he complained of pain to his right shoulder area. He said he had a pre-existing injury to his right shoulder and that he had tore his shoulder a year ago. He said the shoulder never healed right and that he re-injured the shoulder tonight in the struggle.

Upon arrival, Arrestee Carrillo was treated by Dr. Lee and there was a possibility he was going to be admitted. Arrestee Carrillo was cited and released at the hospital with the authorization of the Watch Commander/Acting Commander Sgt Claborn.

**Narrative:**

On Friday, February 26, 2016 at approximately 2117 hours, I heard Cpl Couso request emergency assistance via his radio in reference to him being in a fight with a subject. I responded to 300 S. Figueroa and as I exited my vehicle, I saw Cpl Couso struggling with a male subject in the west parking lot.

I responded to the struggle and placed my left knee on the upper back of the male subject, later identified as Antonio Carrillo. Carrillo was lying on his stomach, thrashing his body back and forth attempting to stand up. I saw Carrillo's right hand was free with a single cuff on his right wrist and the other cuff unsecured. I also saw Carrillo attempting to stand up by placing his left hand under his body. I heard Cpl Couso order Carrillo, "Stop fighting, put your hands behind your back." Carrillo did not comply to Cpl Couso's commands.

Fearing Carrillo was going to stand up and could possibly use the unsecured cuff from his right wrist as a weapon, I punched Carrillo 2-3 times to the left side of his face with my right fist. My strikes seemed to have little effect as Carrillo still attempted to stand up by pushing off the ground with his left hand. I then punched Carrillo twice to his upper back with my right fist, in an attempt to stop him from pushing his body off the ground. Carrillo continued to disobey Cpl Couso's commands to stop resisting and place his hands behind his back. Carrillo continued to thrash his body side to side causing me to lose my balance from my knee on his upper back. I ordered Carrillo to stop resisting and place his hands behind his back but he did not obey my commands. Due to Carrillo not obeying police commands and continuing to resist with police officers with a potential weapon on his right wrist, I again punched Carrillo 2-3 times to the left side of his face with my right fist.

These strikes seemed to have some effect as Carrillo finally stopped attempting to push himself off the ground. Carrillo continued to struggle but I was finally able to pull Carrillo's left arm from under his body and was able to secure Carrillo's left hand behind his back. With assistance we were able to handcuff Carrillo without further incident.

I transported Carrillo the Santa Ana Jail, where he was later booked and processed.

I advised Sgt. Park of my use of force at the scene of the incident.

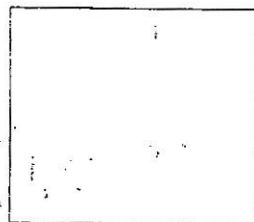
