COUNT 1 – DRIVING UNDER THE INFLUENCE OF ALCOHOL WITHIN 10 YEARS OF ANOTHER DUI OFFENSE

COUNT 2 – DRIVING WITH A .08% BLOOD ALCOHOL CONTENT WITHIN 10 YEARS OF ANOTHER DUI OFFENSE

The undersigned states, on information and belief, that Krystle Hasket, Defendant, did commit a Misdemeanor, a violation of VC23152(b)&23540, Driving With A .08% Blood Alcohol Content Within 10 Years Of Another DUI Offense, committed as follows:

On or about May 16, 2020, in the County of Contra Costa, State of California, the crime of Driving With A .08% Blood Alcohol Content Within 10 Years Of Another DUI Offense in violation of VC23152(b)&23540, a Misdemeanor, was committed in that KRYSTLE HASKET did drive a vehicle while having a 0.08 percent or more, by weight, of alcohol in her blood, and, who, within 10 years of that offense, committed a separate violation of Vehicle Code Section 23152 that resulted in a conviction:

COUNT 3 – HIT AND RUN DRIVING RESULTING IN PROPERTY DAMAGE

The undersigned states, on information and belief, that Krystle Hasket, Defendant, did commit a Misdemeanor, a violation of VC20002(a), Hit And Run Driving Resulting In Property Damage, committed as follows:

On or about May 16, 2020, in the County of Contra Costa, State of California, the crime of Hit And Run Driving Resulting In Property Damage in violation of VC20002(a), a Misdemeanor, was committed in that KRYSTLE HASKET was driving a vehicle involved in an accident resulting in property damage and failed to immediately stop and either (1) locate and notify the owner or person in charge of the damaged property of her name and address and of the owner of the vehicle and present her driver's license and vehicle registration to the other driver, property owner or person in charge of that property; or (2) leave in a conspicuous place on the vehicle or property damaged a written notice giving her name and address and of the owner of the vehicle, along with a statement of the circumstances, and then notify law enforcement.

COUNT 4 – RESIST, OBSTRUCT, DELAY OF PEACE OFFICER OR EMT

The undersigned states, on information and belief, that Krystle Hasket, Defendant, did commit a Misdemeanor, a violation of PC148(a)(1), Resist, Obstruct, Delay Of Peace Officer Or EMT, committed as follows:

On or about May 16, 2020, in the County of Contra Costa, State of California, the crime of Resist, Obstruct, Delay Of Peace Officer Or EMT in violation of PC148(a)(1), a Misdemeanor, was committed in that KRYSTLE HASKET did willfully and unlawfully resist, delay and obstruct Jaime Guzman who was then and there a peace officer attempting to and discharging the duty of his/her office and employment.

COUNT 5 – BATTERY

The undersigned states, on information and belief, that Krystle Hasket, Defendant, did commit a Misdemeanor, a violation of PC242, Battery, committed as follows:

On or about May 16, 2020, in the County of Contra Costa, State of California, the crime of Battery in violation of PC242, a Misdemeanor, was committed in that KRYSTLE HASKET did willfully and unlawfully use force and violence upon the person of Kobi Peled.

Complainant requests that the Defendant[s] be dealt with according to the law.
