<b>Narrative</b> On 21Mar09 about 1320hrs, I was working patrol as 1A23 with Ofc. Turner 9017 when we heard a broadcast for an officer needs assistance on 73rd Ave at MacArthur. We responded code 3 to the scene and initially to a position at 74th Av. at Garfield St. At this post we checked vehicles as they were leaving the area through our position in case the suspect was hiding in one.  After being on this post for about 15minutes we moved to a new location at 75th Ave and Garfield St. We performed the same function here looking at vehicles leaving the area in case the suspect was hiding in one.  We were at that position for about 30minutes before Acting Lt. Alexander advised that the units on Garfield could clear their posts and re-adjust to fill in the gaps in the outer perimeter. Ofc. Turner and I relieved Acting Sgt. Encinas at his post at 75th Av and Outlook Ave. We stayed at this post the rest of the duration of the incident. Ofc. Turner and I documented the vehicles and their drivers at this location that were leaving the area as well as checking to make sure the suspect wasn't hiding in them. (Refer to Ofc. Turner's supplement for the list of driver's and vehicles).  Once the scene was stabilized, per Act. Lt. Alexander's orders we moved from our location to a rally point on 74th Ave and MacArthur Blvd. where we were given instructions to canvas the area of 73rd Ave. between MacArthur Blvd. and Hillside.
