ADMINISTRATIVE RIGHTS - SWORN SUBJECTS

I am Sergeant Erich Hoppe of the Professional Standards Unit. You are about to be questioned as part of an official Santa Cruz Police Department administrative investigation. The investigation concerns an allegation of policy violations:

Policy 320 – Standards of Conduct and Discipline

Policy 300 – Use of Force

If this were a criminal investigation, any statements you made could be used against you in a court of law. Since this is an administrative investigation, neither your statements nor any information or evidence, which is gained by such statements, can be used against you in any subsequent criminal proceeding. However, these statements may be used against you in subsequent administrative actions.

You are being ordered to answer questions specifically related to the performance of your official duties and/or your conduct as related to your employment with the department. I am now giving you an order to answer the questions truthfully and completely as asked.

You have the right to presence and assistance of counsel. You are hereby notified, that although you have the right to remain silent, failure to answer questions directly related to this administrative investigation may result in your discharge or other punitive action.

You have the right to a representative of your choice, who is not involved in this investigation, present with you during your interview. You may tape record this interview if you wish.

You are advised that your rights are fully outlined in the Public Safety Officer's Bill of Rights Act, Government Code Sections 3300 to 3311.




