FACTS ESTABLISHING ELEMENTS AND IDENTIFICATION OF DEFENDANT:

ON 06/16/16 AT ABOUT 2245 HOURS, I RESPONDED TO AN ABANDONED VEHICLE CALL SUBMITTED TO MY INVESTIGATION. I LEARNED THAT THE OWNER OF THE ABANDONED VEHICLE/MOTORHOME WAS JASON SALAZAR. A RECORDS CHECK CONFIRMED THAT SALAZAR HAS ACTIVE PENALTY WARRANTS FOR HIS ARREST, INCLUDING A FELONY CHILD ABUSE WARRANT. DURING MY INVESTIGATION ON 06/16/16, SALAZAR SAW OFFICERS IN THE AREA. HE DESERTED THE VEHICLE HE WAS DRIVING TO AVOID CAPTURE, LEAVING HIS 3-YEAR OLD DAUGHTER UNATTENDED IN THE VEHICLE. SALAZAR'S WIFE INFORMED ME THAT HE HAD ABANDONED HIS DAUGHTER. AFTER A URGENT SEARCH TO FIND THE VEHICLE THAT CONTAINED THE CHILD, IT WAS LOCATED ON 06/16/16 AT ABOUT 0113 HOURS IN A DARK VACANT PARKING LOT. THE CHILD WAS FOUND IN THE VEHICLE; SALAZAR WAS NOT LOCATED. ON 06/16/16 AT ABOUT 1741 HOURS, AN LPR DETECTED SALAZAR'S VEHICLE. I LOCATED THE VEHICLE AND COULD CLEARLY SEE SALAZAR DRIVING. I ADMITTED A TRAFFIC STOP VIOLATION. SALAZAR FLED AND A VEHICLE PURSUIT ENSUED. SALAZAR RAN SEVERAL STOP LIGHTS AND A STOP SIGN, DROVE INTO ONCOMING TRAFFIC, AND PENVE IN EXCESS CAPTURED BY ONTARIO PD ON 06/16/16 IN THE CITY OF ONTARIO. HE WAS LATER
