Narrative

On 21MAR09 at about 1330 hrs I was working as 4L16. I was wearing my full police uniform and driving marked patrol vehicle #1750. I responded to 75th Ave and Macarthur Blvd to assist officers with an officer involved shooting.

Upon arrival to 75th Ave and Macarthur Blvd I was directed by Sgt. Covington to take custody of a witness (b)(5)(B) that he located in the area of 75th Ave and Macarthur Blvd. I briefly spoke with (b)(5) who stated that following:

On 21MAR09 at about 1316 hrs (b)(5) was traveling in his vehicle E/B in the 7400 blk of Macarthur Blvd (b)(5) observed a MB running S/B across Macarthur Blvd and continue S/B on 74th Ave. (b)(5) observed the individual trying to conceal a firearm in his front waistband. (b)(5) continued to travel E/B on Macarthur Blvd and noticed two police officers laying on the ground with apparent gun shot wounds to the face and neck area. (b)(5) exited his vehicle and stayed in the area for police arrival.

I subsequently transported (b)(5) to Homicide at the RAB. While at Homicide I assisted with checking on several witnesses that
